Used Tire Transportation Registration number T7626 is hereby issued to Inter-Rail Systems, Inc. to engage in used and waste tire hauling in the State of Illinois, utilizing only the vehicles identified in the Used Tire Transportation Registration Application (UTTRA) received by the Illinois EPA on December 13, 2017. A copy of your UTTRA is enclosed with this registration.

This Used Tire Transportation Registration is issued in accordance with 35 Ill. Adm. Code Part 848 Subpart F of the Illinois Pollution Control Board's regulations. This registration is valid from December 22, 2017 through March 31, 2020, for all vehicles listed on the UTTRA. In order for this registration to be valid, all vehicles listed on the UTTRA must be properly placarded in accordance with the placarding requirements in 35 Ill. Adm. Code Part 848.606, which are detailed in an enclosure with this letter.


Please count your enclosed expiration seals. The Agency must be notified of any shortages within three working days of receipt of your registration in order for us to send additional seals. If seals are destroyed, send a letter of explanation and fragments of the destroyed seal(s), along with photographic documentation, and we will replace the seal(s). If the Agency is not contacted within the 3-day period and/or sent evidence of a destroyed seal, you may be required to resubmit your application.

Please note, the Illinois EPA no longer sends notices of expiration of your existing registration. It is your responsibility to keep track of your expiration date and submit a renewal application at least 120 days prior to the expiration date of your current registration. All applications must be submitted on the current UTTRA form. As a registered used tire transporter in Illinois, you are required to use a Tire Tracking Receipt for all receipts and deliveries of used tires. In addition, as a registered used tire transporter in Illinois, you must submit an Annual Tire Transportation Report to the Illinois EPA by March 1 for the preceding calendar year.
